

BID BULLETIN NO. 2 FOR THE SECOND GREEN ENERGY AUCTION ROUND (GEA-2)

1. GEA-2 TIMELINE OF ACTIVITIES:


The DOE hereby amends the schedule of activities for the GEA-2, as follows:

Activities	Old Timeline	New Timeline
Last day of Registration of Qualified Suppliers*	12 May 2023	19 May 2023
Evaluation of Qualified Suppliers	15-17 May 2023	22-24 May 2023
Posting of Qualified Bidders	24 May 2023	01 June 2023
Pre-Bid Conference for Qualified Bidders	29 May 2023	06 June 2023

Note: The registration is final considering that the registration does not entail and is not consequential to additional obligation but a mere intention to participate/join.

Thus, the GEA-BEAC shall notify the potential Suppliers who failed to comply with the registration requirements on **25-26 May 2023** and the said Suppliers may file a Request for Reconsideration within two (2) calendar days upon receipt of the said notice.

3. REGISTRATION OF QUALIFIED SUPPLIER

Clarification on Clause 2.2.1 of the Terms of Reference (TOR):

A proponent of an RE project who filed a Letter of Intent to apply for an RE contract (LOI) prior to the integration of the pre-application process in the EVOSS platform, and who has been issued with a Notice to Proceed, may also register the project covered by the LOI in the GEA-2. After the integration of the pre-application process in the EVOSS platform, only an LOI filed through EVOSS may serve as the basis for registration.

4. PERFORMANCE BOND (ANNEX B.2)

- B.2. Performance Bond in any of the forms enumerated below may be accepted:
 - a. Cash or Manager's Cheques issued by universal or commercial banks:
 - b. Irrevocable Letter of Credit issued by universal or commercial banks; and
 - c. Surety Bond issued by an insurance company duly certified by the Insurance Commission.

If the Performance Bond is in the form of Cash or a Manager's Cheque, the total amount thereof shall cover twenty percent (20%) of the project cost per MW multiplied by the offered capacity in MW, but not less than Php5Million for a bid of less than 1MW.

If the Performance Bond is in the form of a Surety Bond, the total amount shall cover thirty percent (30%) of project cost per MW multiplied by the offered capacity in MW, but not less than Php 5Million for a bid of less than 1MW.
